No............Whereas Master Plan of Local Planning Area Amritsar has already been notified u/s 70 (5) of The Punjab Regional and Town Planning and Development Act, 1995 vide notification no. 8582 CTP(Pb) SA-152 dated 10-12-2012. While implementing the proposals of the Master Plan Amritsar, it has come to the notice of Government of Punjab that the hospital activity is not permissible in industrial zone of Master Plan Amritsar. Whereas in other Master Plans like Master Plan Jalandhar, Master Plan Patiala, Master Plan Ludhiana, etc hospital activity is permissible in industrial zone as per the zoning regulations of these Master Plans. Therefore to bring parity in Master Plans of different cities and keeping in view the public interest, Government of Punjab u/s 76 of the Act ibid in consultation with 'The Punjab Regional and Town Planning and Development Board's' 30th meeting held on 09-12-2015 has decided to allow hospital activity in Industrial Zone of Master Plan Amritsar also. However, the hospital which comes up in industrial zone will have to create a buffer of 15 meters from the area where any red category industry can come up. This buffer would have plantation of thick broad leave trees in case it is not a public road which acts as buffer.

This amendment is hereby notified u/s 70(5) of The Punjab Regional and Town Planning and Development Act, 1995

It shall come into operation from the date of its notification.
