NOTIFICATION


No.....Whereas the Master Plan of Local Planning Area Ludhiana (2007-2031) has already been notified u/s 70 (5) of The Punjab Regional and Town Planning and Development Act, 1995 vide notification no. 7466 CTP (Pb)/ SL-65 dt 12/9/2008. During its implementation, it was brought to the notice of Government by M/s Akme Projects Ltd., that Empowered Committee in its Meeting dated 28.02.2006 has already approved their Mega Residential project of 80.00 acre at village Jandiali (H.B. No. 225), out of which the layout plan of an area of 77.1678 acre has already been approved by the Competent Authority. But while preparing Master Plan Ludhiana the area of their project has been covered under industrial zone, although as per the provisions of Master Plan Ludhiana the site of their approved project stands accommodated in the Master Plan. Now company wants to add an area of 2.725 acres to their existing residential project which falls under industrial zone of master plan and for this purpose the company has requested the Government to allow it the change of land use of their 2.725 acre land falling in khasra no. 40//12,13,14/1/1,14/2/1,14/2/3,7/2/2,8/2,9/1 from industrial zone to residential zone. The area of 2.725 acres is not only enclosed on three sides by the already approved Mega Residential Project but is also within the preview of 80 acres for which approval has already been granted by the Empowered Committee. The request of the company was accepted and a public notice in this regard was published in newspapers dated 5.08.2015 for inviting public objections/ suggestions but no objection was received during the stipulated period of 30 days.

Therefore, the Government u/s 76 of the Act ibid in consultation with 'The Punjab Regional and Town Planning and Development Board's 30th meeting held on 09-12-2015, has approved the change of land use of the above said pocket of 2.725 acres from Industrial zone to Residential zone in Master Plan Ludhiana.

This amendment has been shown on Revised Drawing No. DTP(L) 29/2015 dated 31-12-2015. Which is hereby notified u/s 70(5) of The Punjab Regional and Town Planning and Development Act, 1995

It shall come into operation from the date of its notification.




