**No. 6/1/2009-6HG1/385857/1** Whereas the land acquisition proceedings were initiated vide notification no. 6/1/09-1HG1/2264 dated 10.08.2009 issued under Section 6 of the Land Acquisition Act, 1894 (since repealed) for acquisition of land measuring 89.37 Acre of Village Mullanpur Garibdas 40.42, Ferozpur Bangar 13.38, Parol 16.58, Hoshiarpur 17.38 and Majra 1.61 (Total Area 89.37 Acre) for the public purpose of namely construction/upgradation of road from punjab/UT border (near Mullanpur) to Siswan T-Junction in Local planning Area of Mullanpur.

Whereas the possession of the land comprised in the above said notification, was taken vide award No. 507 dated 31-03-2010 and now the Government of Punjab has decided to denotify the above said notification issued under section 6 of the Land Acquisition Act, 1894 as the area belongs to Central Government (In the name of Defence).

Whereas the said Act of 1894 has since been repealed by the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and further action is to be taken under this new Act.

Now, therefore, in exercise of powers conferred under Section 93(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Governor of Punjab is pleased to withdraw the land acquisition proceedings initiated vide notification no. 6/1/09-1HG1/2264 dated 10.08.2009 issued under section 6 of the Land Acquisition Act, 1894 for acquisition of land measuring 4 Bigha 12 Biswa out of 89.37 acres for the public purpose of namely construction/upgradation of road from punjab/UT border (near Mullanpur) to Siswan T-Junction in Local planning Area of Mullanpur.
