**No 6/22/2009-6HG1/385867/1** Whereas the State Government had acquired the land comprising Khasra Nos. specified land acquisition proceedings were initiated vide notification no. 6/22/2009-6HG1/1288 dated 10.05.2010 issued under Section 6 of the Land Acquisition Act, 1894 (since repealed) for acquisition of land measuring 419.9519 Acre of Village Mullanpur Garibdas 114.5625, Ratwara 0.7687, Ferozpur Bangar 17.0062, Bharonjia 100.9375 and Devi Nagar 186.6770 (Total Area 419.9519 Acre) for the public purpose of namely Setting up Residential Urban Estate, Mullanpur in the area of Revenue Estate of Tehsil Kharar, District SAS Nagar.

Whereas the possession of the land comprised in the above said notification, was taken vide award No. 518 dated 02-08-2011 and now the Government of Punjab has decided to denotify the above said notification issued under section 6 of the Land Acquisition Act, 1894 as the area belongs to Central Government (In the name of Defence).

Whereas the said Act of 1894 has since been repealed by the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and further action is to be taken under this new Act.

Now, therefore, in exercise of powers conferred under Section 93(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Governor of Punjab is pleased to withdraw the land acquisition proceedings initiated vide notification no. 6/22/2009-6HG1/1288 dated 10.05.2010 issued under section 6 of the Land Acquisition Act, 1894 for acquisition of land measuring 3 Bigha 2 Biswa out of 419.9519 acres for the public purpose of namely Setting up Residential Urban Estate, Mullanpur in the area of Revenue Estate of Tehsil Kharar, District SAS Nagar.
