No. 13/31/2007-6HG2/ 572 in partial modification of Notification No. 13/31/2007-6HG2/2470 dated 24th August 2010, the Governor of Punjab is pleased to redefine the boundaries of Bathinda Development Authority, Bathinda (BDA), under section 29(2) of the Punjab Regional and Town Planning and Development (Amendment) Act, 2006 and all other powers enabling him in this behalf. The jurisdiction of Bathinda Development Authority shall include the areas of revenue Districts of Bathinda, Mansa, Faridkot, Shri Muktsar Sahib and Fazilka. The extent of Area and amended schedule of boundary shall be as follows:-

EXTENT OF AREA:

Revenue Districts of Bathinda, Mansa, Faridkot, Shri Muktsar Sahib and Fazilka.

SCHEDULE OF BOUNDARY

- North:** District Firozpur and Moga (From point 'A' to point 'B')
- East:** District Barnala and Sangrur (from point 'B' to point 'C')
- South:** States of Haryana and Rajasthan up to South West Corner or District Fazilka (from point 'C' to point 'D')
- West:** State of Rajasthan and International Border with Pakistan (Point 'D' to Point 'A')

The amended boundaries of Bathinda Development Authority Bathinda are shown on the drawing no. DTP (B) 1672/2013 dated 23.08.2013.
