No. Whereas in order to develop Sri Mukatsar Sahib and its surroundings in an orderly manner, and to prepare Master Plan under "The Punjab Regional and Town Planning and Development Act, 1995, Local Planning Area, Sri. Mukatsar Sahib was declared vide Notification No. 12/76/2006-4HGI/2704, dated 09.04.2008 & Notification no. 12/76/06-4HGI/2146 dated 2/7/2010 under section 56 (1) & (7) of the Act ibid.

Whereas Chief Town Planner, Punjab, was declared as Planning Agency for aforesaid Local Planning Area under section 57 of "The Punjab Regional and Town Planning and Development act 1995" vide notification No. 12/76/2006-4HGI/2710. dated 09/4/2008

Whereas Planning Agency prepared the Master Plan for Local Planning Area, Sri Mukatsar Sahib and published the same in news paper on 28.05.2014 under Section 70 (3) of "The Punjab Regional and Town Planning and Development Act, 1995", for inviting objections from the general public.

Whereas objections received from the general public were considered by the Government in consultation with The Punjab Regional and Town Planning and Development Board in its 29th meeting held on 15.04.2015 approved the Master Plan, Sri. Mukatsar Sahib.

Now, therefore in exercise of powers conferred under Section 70 (5) of "The Punjab Regional and Town Planning and Development Act, 1995" final Master Plan, Sri Mukatsar Sahib comprising written report and drawings namely Existing Landuse Plan-2010 Drawing No. D.T.P (FDK) 377/2010 dated 20/12/2010, Proposed Landuse Plan (2010-2031) Drawing No. D.T.P (FDK) 403/2013 dated 12/12/2013 and Proposed Transport Network Plan Drawing No. D.T.P (FDK) 404/2013 dated 12/12/2013, are hereby notified.
