1/1/2014-6Hgl/ 890 Whereas in the past few years, tourism and theme destination have emerged as major drivers for economic growth of many countries all around the world;

Whereas promotion of tourism/theme destination in the State of Punjab will not only attract tourists from within the country and abroad, but will also attract investors and hence increase revenue and economic growth of the State;

Whereas serious efforts are required to exploit the huge potential of sub mountainous regions along Shivalik Hills falling in Districts of S.A.S Nagar, Ropar, Hoshiarpur, Pathankot and Gurdaspur for developing tourism/theme destination projects in the State;

Therefore, in order to develop one such area around Thein Dam along Ranjit Sagar Lake as tourism/theme destination project in the State, the Governor of Punjab is pleased to constitute Shivalik (Dhauladhar) Tourism Development Board under Department of Housing and Urban Development. The said Board would be headed by an IAS Officer not below the rank of Administrative Secretary who would act as CEO of the board. He would have a minimum term of three years as CEO. The composition of the board would be as under:

PIDB would give grant of Rs. 10.00 Crores initially to the board to enable it to start functioning as a cohesive unit.
